Are you a Harvard graduate student interested in tackling issues of educational equity, intergenerational poverty, and economic mobility in communities across the country? Driven by the vision that race, place, and income should no longer be determinants of school and life success for children and young people, The EdRedesign Lab (EdRedesign) at the Harvard Graduate School of Education (HGSE) is working to change practices, policies, and systems so that more young people can reach their full potential in school and in life.

EdRedesign is seeking motivated and talented students to join our team for the Fall 2025 semester, with the possibility of extension for the Spring 2026 semester contingent on performance and needs.

Founded in 2014 by Paul Reville, former Massachusetts Secretary of Education and Professor of Practice of Educational Policy and Administration at HGSE, EdRedesign provides catalytic support to the cradle-to-career place-based partnership field to drive systems-level change and open personalized pathways to well-being, educational attainment, civic engagement, and upward mobility. Our mission is to ensure the social, emotional, physical, and academic development and well-being of *all* children and youth, especially those affected by racism, poverty, and disinvestment.

The landscape of opportunities for children, youth, and families is vastly inequitable throughout our nation. Factors *outside* of school explain much of the variance in well-being, educational attainment, and upward mobility, yet efforts to achieve equity for children and youth have largely focused on changing what happens *in* school (where children from kindergarten through 12th grade spend only 20% of their waking hours). While we need good schools, we need strategies that go beyond schools to ensure that all children and youth thrive.

We believe strategies to expand opportunities for children and youth have two critical components: **place-based, cross-sector collaboration** to remove structural barriers and open pathways to opportunity; and **personalized, relationship-based supports**, what we call **Success Planning**, for children and youth to reach their full potential.

To support this growing field to effect transformational change that serves the needs and talents of individual children and youth, our work focuses on talent development, actionable research, our Institute for Success Planning, and our *By All Means* initiatives.

Project Overview

Success Planning is a relationship-based approach that connects each child or youth to an adult Navigator who co-creates a personalized plan for action in partnership with their families and other caring adults. The plan highlights the child's needs and strengths and identifies supports, enrichments, and other resources to remove barriers, build on their strengths, and support their goals. Through a whole-child approach, Success Planning provides a mechanism to ensure every child is known, seen, and heard, has a positive connection to a caring adult, and has agency over their pathway to success.

EdRedesign's Institute for Success Planning Community of Practice provides cross-sector teams of leaders from across the country an opportunity to access support, build capacity, network, share ideas, and co-create promising practices that will inform implementation and scaling of their local Success Planning initiatives. By creating space for collaboration, participants gain a deeper understanding of the key components, principles, and practices of Success Planning. The Community of Practice also creates a close-knit community of peers and fosters a learning environment that cultivates trusting relationships. Local community leaders build their capacity to create transformational change for children within their communities by creating, expanding, or improving personalized, relationship-based systems of support for all children.

- Assist the Director of the Institute for Success Planning, the Director of Education Strategy & Cross-Sector Community Impact, and the Senior Program Coordinator with assigned administrative and event planning tasks to support the work of the Institute.
- Attend Success Planning meetings and broader related EdRedesign staff meetings.
- Participate in and support webinars, convenings, and other Success Planning activities, if available.
- Based on previous experience, skills, and expertise, the Institute for Success
 Planning Community of Practice Intern may assist with special projects related to
 particular communities, engage in presentations, facilitate activities, engage in
 coaching and technical assistance sessions with local communities participating in
 the Community of Practice, or work with EdRedesign's research and
 communications teams on projects related to Success Planning.
